| 1. A student may only drive a private vehicle onto and /or park on school property for the purpose of attending school and must have a UAHS Student Driver Permit | AFTER SCHOOL DETENTION | SUSPENSION FROM SCHOOL (for a period determined by the Principal) |
| 2. Students may only drive onto school property in vehicles that are covered by third party property insurance or comprehensive Insurance | AFTER SCHOOL DETENTION | SUSPENSION FROM SCHOOL (for a period determined by the Principal) |
| 3. Student must drive in a "safe" manner at all times on or near the school property. They must obey all road signs and speed limits on or near the school and drive with due care | AFTER SCHOOL DETENTION & 3-6 UAHS STUDENT DERMIT POINTS Possible SUSPENSION OF THE STUDENT DRIVER PERMIT POSSIBLE POLICE INVOLVEMENT | SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period determined by the Principal) and/or POLICE INVOLVEMENT and or SUSPENSION FROM SCHOOL (for a period determined by the Principal) |
| 4. Student may only carry passengers to and from school and only with proper school authorisation. Carrying unauthorised passengers in a student's vehicle is a serious breach of the School's Transport Policy. Unauthorized passengers have the same penalty. | AFTER SCHOOL DETENTION & 3 DERMIT POINTS & SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period no less than two weeks <u>after</u> the detention for the offence has been served) | SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period determined by the Principal) SUSPENSION FROM SCHOOL (for a period determined by the Principal) |

NB: Authorisation for carrying passengers during the school day, may be granted once the required forms have been completed, received and approved by the Student Driver Coordinator.

NB : Approval to carry a 'temporary passenger' or a 'one off' trip is possible with written permission from both sets of parents and with the consent of the school.

| <p>5. Student drivers may only leave the school in their vehicle after the last scheduled lesson of their school day . | <p>6. All private vehicles driven by students to school and parked on school property must:-</p> <p>a) Have a UAHS parking Permit clearly displayed on the windscreen of the vehicle.</p> <p>b) Be parked in an appropriate manner in the appropriate location for their permit.</p> | <p>LUNCHTIME DETENTION and TWO UAHS STUDENT DRIVER DEMERIT POINTS</p> | <p>AFTER SCHOOL DETENTION & FOUR UAHS STUDENT DRIVER DEMERIT POINTS</p> |
| <p>7. Students may not drive in unauthorised areas of the school without permission. This includes the farm/machine shop precinct . Students must enter and leave from the gate adjacent to their assigned parking area and are not to drive 'through' the school.</p> | <p>LUNCHTIME DETENTION and TWO UAHS STUDENT DRIVER DEMERIT POINTS</p> | <p>AFTER SCHOOL DETENTION & FOUR UAHS STUDENT DRIVER DEMERIT POINTS</p> |
| <p>8. Year 12 student drivers ONLY may return to their vehicles throughout the day. All other students may only be in parking areas of the school when authorised. Loitering or being a nuisance in these areas is forbidden.</p> | <p>LUNCHTIME DETENTION and TWO UAHS STUDENT DRIVER DEMERIT POINTS</p> | <p>AFTER SCHOOL DETENTION & FOUR UAHS STUDENT DRIVER DEMERIT POINTS</p> |
| <p>9. Students must complete detentions for offences as set</p> | <p>SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period no less than two weeks <u>after</u> the detention for the offence has been served)</p> | <p>SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period determined by the Principal)</p> |
| <p>10. Accumulating more than five student driver demerit points</p> | <p>SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period no less than two weeks <u>after</u> the detention for the offence has been served)</p> | <p>Any subsequent offence: SUSPENSION OF THE STUDENT DRIVER PERMIT (for a period determined by the Principal)</p> |
